Whereas the owner of the property known as lot 3 206 133 of the cadastre of Quebec is not using the main building in conformity to municipal regulation on said lot, specifically the use and location of three (3) dwellings;

Whereas the owner of said property has done work which does not comply with the permit issued by the Municipality;

Whereas the Municipality issued a formal notice to the property owner in order for them to proceed with the removal of the third dwelling and present a plan for an accessory dwelling;

Whereas the property owner has presented a request for a zoning change which did not obtain the municipal council's approval as per resolution 89.04.18 adopted on April 11th, 2018;

Whereas the property owner refused to comply with the Municipality's requests;

Whereas this matter contravenes to municipal regulation and is the basis of an appeal initiated as per Articles 227 and following of the *Loi sur l'aménagement et l'urbanisme*;

Consequently, it is proposed by Councillor Louise Cossette And unanimously resolved by all councillors:

That the municipal council mandate the firm Prévost, Fortin D'Aoust in order for all of the appropriate legal proceeding be initiated before the Quebec municipal court and for all uses of a third dwelling within the main building located on lot 3 206 133 within the cadastre of Quebec for said dwelling to be dismantled in order for the accessory dwelling's development to be presented.

122.05.18 DOCKS – LAC VERT

Considering at the time of the last inspection, it was confirmed that the four docks that were installed on municipal property were still there;

Considering that no action was taken the owners pursuant to a notice sent to them in the Fall of 2017 asking them to remove the dock from municipal property;
