Considering the Municipality of Mille Iles has proposed to enter into a mutual assistance agreement for fire protection services;

Considering this agreement meets the terms of an agreement signed by all of the municipalities of the MRC des Pays-d'en-Haut;

It is proposed by Councillor Leigh MacLeod And unanimously resolved by all Councillors:

That Council authorize the conclusion of an intermunicipal mutual assistance agreement with the Municipality of Mille Iles and that the Mayor and the Director general be authorized to sign for and in the Municipality's name.

183.09.10 ADOPTION OF BY-LAW 474 WHICH AMENDS BY-LAW 264 REGARDING FIRES

The director general reads the by-law.

It is proposed by Councillor Leigh MacLeod And unanimously resolved by all Councillors:

That by-law 474 be adopted as follows:

BY-LAW 474 WHICH AMENDS BY-LAW 264 REGARDING FIRES

- WHEREAS article 62 of the Municipal jurisdiction Act, L.R.Q., c C47.1, the Municipality may adopt by-laws with regards to safety;
- WHEREAS the burning of grass, brush, which becomes out of control constitutes a danger to the population, housing, forests and may occasionally cause major losses;
- WHEREAS smoke coming from open air fires is a source of pollution and inconveniences many people who have respiratory problems;
- WHEREAS a notice of motion of the present by-law was given by Councillor Leigh MacLeod at the regular meeting of May 12th, 2010;

The following is ordained, statued and decreed by the present by-law:

ARTICLE 1

Only burning activities, for private purposes, in order to eliminate forest waste (branches, trees, shrubs, tree trunks, felled trees or other natural wood) pursuant to the cleaning of a property which has been built on or not is authorized.

It is specifically prohibited to burn debris, construction material or any toxic material.

The clearing of a property is not to be compared to a forest clearing residue activity.

ARTICLE 2

Any material destined to be burned must be piled in stacks of approximately 2 meters by 2 meters maximum and not exceeding 1 meter in height and be located on the same property where the forest cleaning activities are being done.

One fire per location is authorized at one time.

ARTICLE 3

The following fires are permitted and do not require the issuance of a permit but are subject to the present by-law:

- Fires contained in outdoor cooking devices such as fire places, barbecues and other devices for these purposes;
- Fires in metal containers such as barrels or other with spark-proof covers;
- Camp fires to keep mosquitos away, for pick-nicks or country parties must not exceed a surface area of 1 square meter and must be more than ½ meter in height and must be surrounded by non-flammable materials.

ARTICLE 4

The Director, Fire Department or his representative may issue a special permit for a fire which exceeds the dimensions stipulated in Article 2 for an event or social celebration.

ARTICLE 5

Anyone who would like to make a fire must beforehand have obtained a burning permit from the Director, Fire Department or his representative during the municipal office business hours.

ARTICLE 6

The following information must be obtained at the time of the request:

- Name and address of the person in charge of the fire;
- A mandate from the property owner if he is not the person responsible for the fire;
- Location where the fire will take place;
- Date when the fire will take place;
- Description of the material to be burned;
- Precautions must be taken in order to ensure the control of the fire(s) as well as the ways the fires will be extinguished.

ARTICLE 7

The Director, Fire department will inspect properties which are not supplied with water before the issuance of a permit.

Permits will not be issued in the following cases:

- When the wind exceeds 25 km/hour;
- When there is a restriction for lighting open fires issued by competent authorities;
- When one of the conditions stipulated in the present bylaw is not being respected;
- When the necessary equipment for the complete extinction of the fire(s) is not available on site of the burning activities.

ARTICLE 8

The permit issued as per the present by-law is only valid for a maximum period of four days at a time.

ARTICLE 9

Having obtained a fire permit does not release the person that obtained the permit of his usual responsibilities in the case where monies or damages which may result from the fire having been lit.

ARTICLE 10

The person responsible for the fire must supervise the fire at all times and ensure that before leaving the premises, said fire is completely extinct with water or completely buried.

ARTICLE 11

Any outdoor fire that may be a nuisance to neighbouring properties because of smoke, soot, unpleasant debris, odors or other harmful or toxic substances constitutes a nuisance and must be extinguished without delay pursuant to a notice from a municipal representative.

ARTICLE 12

Anyone setting a fire and not taking the necessary measures to prevent the fire from spreading from his property to neighbouring properties, commits an offence as per the present by-law and is liable to all penalties provided for by law.

ARTICLE 13

Anyone who infringes to one or the other of the specifications of the present by-law commits an offence and renders the offender liable a minimum fine of \$ 100 for a first offence if the offender is a physical person and of \$ 500 for a first offence if the offender is a moral person; a minimum fine of \$ 500 for a repetition if the offender is a physical person and a minimum find of \$ 1,000 for a repetition if the offender is a moral person; the maximum fine which may be prescribed is \$ 1,000 for a first offence if the offender is a moral person; the offender is a physical person and of \$ 2,000 for a first offence if the offender is a moral person; for a repetition, the maximum fine if of \$ 2,000 if the offender is a physical person and of \$ 4,000 if the offender is a moral person.

In every case, fees for legal proceedings will be additional.

The delays for payment of the fines and costs prescribed as per the present article, and the consequences for failure to pay said fines and costs within the stipulated delays, are established in accordance to the «Code de procédure pénale du Québec» (L.R.Q., c. C-25.1).

If an offence lasts for more than one day, the offence committed on each day constitutes a distinct offence and the penalties decreed for each offence may be prescribed for each day that the offences may be committed, in accordance to the present article.

ARTICLE 14

Those responsible for the enforcement of the present by-law are : the Director, Fire Department, the Director, Urbanism Department, the Director, Environment Department, the Director, Public works, the building inspector and the foreman of the Public works Department.

The municipal Council authorizes all of the Sûreté du Québec police officers to undertake legal proceedings against anyone who intervenes and to issue infringement notices for any offence to any of the provisions of the present by-law.

ARTICLE 15

The present by-law replaces for all rights and purposes all regulatory provisions of by-laws pertaining to open air fires, by-laws 264-98 and 358.

ARTICLE 16 The present by-law enters into effect as per the Law.

185.09.10 CHRISTIEVILLE DAM

Considering the Municipality had to modify the repair to the Christieville dam project pursuant to decisions made by the Minister of sustainable development, Environment and parks and the Minister of natural resources;

Considering the project now pertains to the demolition of the remnants of the Christieville dam, as presented in the authorization request dated July 21st, 2010;

Considering the letter received from Mrs. Valérie D. Dufour, biologist, from the Minister of sustainable development, environment and parks dated August 19th, 2010;

It is proposed by Councillor Jean Dutil And unanimously resolved by all Councillors:

That Council authorize the Director general to present a request for authorization certificates to the Minister of sustainable development, environment and parks and to act as the Municipality's representative with regards to the concerned ministers.

That Council approve the terms of the request presented on July 21st, 2010 to the Minister of sustainable development, environment and parks.

That Council agree to respect the terms for the repairs as described in Mrs. Dufour's letter dated August 19th, 2010.

186.09.10 LAND – AQUEDUC BASTIEN

188.09.10 NAGECO – GENIVAR, ENGINEERS – ALPINO DAM

189.09.10 CONTRACT – CONSTRUCTION OF ALPINO DAM

Considering the work must be done during the low water period in order to comply with the provisions of the Minister of sustainable development, environment and parks' certificate of authorization;

It is proposed by Councillor Peter MacLaurin And unanimously resolved by all Councillors:

That Council authorize the Director general to enter into an agreement for the repair work to the lowest bidder in conformity pursuant to the engineer in the dossier's analysis of the offers;

That this delegation of expenses be only valid as per borrowing by-law 475.

That this resolution will enter into effect upon receipt of the approval of the By-law by the Minister of municipal affairs, regions and land occupancy.

190.09.10 ECHORIDGE PARK

Considering a group of property owners of 33 acres identified as « The Echoridge land » have presented the Municipality with an offer to transfer, free of charge;

Considering this property has a recreational vocation but mostly is for protection and ecological preservation of the Lac Echo area;

It is proposed by Councillor Leigh MacLeod And unanimously resolved by all Councillors:

That Council delegate the Mayor and Director general in order to enter into a transfer agreement with the property owners of Echoridge SENC represented by Mr. André Poirier, which will be the subject of Council's subsequent approval.

That Council approve in principle, the issuance of a receipt for a donation to the Municipality.
