## BY-LAW 513-2014 PAVING WORK IN DOMAINE DES BORIES AND A LOAN OF \$ 261,400 IN ORDER TO DO SO

WHEREAS, as per the provisions of Articles 711.21 and following of the Quebec municipal Code, every municipality is responsible for managing every road or part of road located on its territory;

WHEREAS the citizens of the area have asked that a paving project be presented;

WHEREAS the Municipality intends to support the citizens of the area who accept to financially participate in the local improvement of the roads network by decreeing infrastructure work by by-law 514-2013;

WHEREAS a notice of motion for this by-law was given at the regular council meeting of April 9th, 2014 by councillor Jean Dutil with the exemption of its reading;

THAT THE FOLLOWING BE STATUED AND ORDAINED BY THE PRESENT BY-LAW, as follows:

The preamble forms an integral part of the present by-law.

#### ARTICLE 1

Council decrees an expense not exceeding the amount of \$261 400 for the applying of the present by-law, specifically the carrying-out of the paving work and reloading of gravel on des Bories, Cahors, Chauvenet and de la Savoie roads and in order to obtain this amount, authorize a loan by notes for the same amount for a period of 20 years; the estimated quote dated March 20th, 2014, prepared by Mr. Alain Bérubé, ing. Director of the public works department, attached herewith as Annex A, forming an integral part hereof.

#### ARTICLE 2

If any of the appropriations of the present by-law is more than the expense which is made pertaining to the appropriation, Council is authorized to use this surplus to pay for other expenses decreed by the present by-law and for which the estimate is proved to be insufficient.

### **ARTICLE 3**

To provide for the expenses committed pertaining to interests and reimbursement in capital of the annual due date of the loan, is by the present by-law levied each year, during the term of the loan from each property owner of a taxable property bordering des Bories, Cahors, Chauvenet and de la Savoie roads, where the work will be done, as shown on the plan of the road and the list of properties attached herewith as Annex B of the present by-law which forms an integral part hereof, a compensation for each taxable property for which is the owner.

The amount of this compensation will be established annually by dividing the allotted expenses with regards to interests and the reimbursement of the capital at the loan's annual due dates by the number of taxable properties for which the owners are subject to paying this compensation.

#### **ARTICLE 4**

Every property owner for which a compensation is to be levied as per Article 3, may exempt this property of this tax by paying in one instalment, part of the capital relating to this loan before the issuance of this loan or any other subsequent issuance, if applicable and which would have been supplied by the compensation required by said article.

The payment must be made within thirty days of the issuance of the notice sent by the Municipality and forwarded by mail to property owners aimed by the present by-law.

The deduction of the special tax levied by the present by-law will be deducted in accordance. This payment must be made in accordance to Article 1072.1 of the Quebec municipal Code.

The payment made before the above-mentioned term exempts the property of the special tax for the remainder of the term of the loan set by this by-law.

The present by-law enters into effect by the Law.

That Council grant the derogation, specifically, to increase the authorized encroachment within the 20 meters setback for the high water mark of a lake, from 1,5 meters to 4 meters for a gallery and from 1,2 meters to 3 meters for the stairs; and reduce the 15 meter depth to 8,85 meters for a gallery and from 15 meters to 14,22 for the stairs; and increase the authorized encroachment of 20 meters from the high water mark of a lake for a bay window, from 0,60 meters to 3,1 meters, as shown on the certificate of location prepared by surveyor Sylvie Filion, minutes 4311.
